Pursuant to Article 13 of the General Data Protection Regulation - Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data (hereinafter "GDPR"), we hereby provide you with some information concerning the processing of your personal data provided as part of the relationship with RISCO S.p.A.

We hereby inform you of the existence of some rights provided by the GDPR on personal data and the related processing that you can request from the Controller.

Right	Description	Method of exercising the
Right of access to data (art. 15)	You can request a) the purposes of the processing; b) the categories of personal data in question; c) the recipients or categories of recipients to whom the personal data have been or will be disclosed, in particular if recipients of third countries or international organisations; (d) where possible, the foreseen retention period of the personal data or, if not possible, the criteria used to determine this period; e) the existence of the right of the data subject to request the data controller to rectify or erase personal data or limit the processing of personal data concerning him/her or to object to their processing; f) the right to lodge a complaint with a supervisory authority; g) if the data are not collected from the data subject, all information available on their origin; (h) the existence of an automated decision-making process, including the profiling referred to in article 22, paragraphs 1 and 4 and, at least in such cases, significant information on the logic used and the importance and expected consequences of such processing for the data subject. You have the right to request a copy of the personal data being processed	Forms on the website
Right of rectification (art. 16)	You have the right to request the correction of inaccurate personal data concerning you and to have incomplete personal data completed	Forms on the website
Right to erasure (right to be forgotten) (art. 17)	You have the right to obtain from the Controller the erasure of personal data concerning you if the personal data are no longer necessary in relation to the purposes for which they were collected or otherwise processed	Forms on the website
Right to restriction of processing (art. 18)	You shall have the right to obtain from the Controller restriction of processing when you have contested the accuracy of the personal data (for a period enabling the Controller to verify the accuracy of the personal data) or if the processing is unlawful but you oppose the erasure of the personal data and request the restriction of their use instead, or the Controller no longer needs the personal data for the purposes of the processing, but they are required by you for the establishment, exercise or defence of legal claims. Right to object (art. 21)	You have the right to object, in whole or in part, at any time to the processing of your personal data if the processing is carried out for the pursuit of a legitimate interest by the Controller or if the processing be carried out for Statistical, commercial, promotional and marketing purposes. Right to lodge a complaint with the Italian Personal Data Protection Authority (art. 77)	You have the right to lodge a complaint with the Supervisory Authority if you believe that the processing concerning you infringes the GDPR.	

The exercise of the aforementioned rights is subject to the limits, rules and procedures established by the GDPR, which the Data subject must know and implement. In accordance with the provisions of article 12, paragraph 3, furthermore, the Controller will provide the data subject with information concerning the action taken without undue delay and, in any case, no later than one month after receiving the request. This deadline may be extended by two months, if necessary, taking into account the complexity and the number of the requests. The Data Controller shall inform the data subject of this extension, and of the reasons for the delay, within one month from receipt of the request.
